

Associated Employer Participation Deed

BETWEEN

Lincoln Sentry Group Pty Ltd ABN 59 010 624 389 of 1956 Dandenong Rd, Clayton, Victoria (**New Associated Employer**)

AND

DuluxGroup (Australia) Pty Ltd ABN 67 000 049 427 of 1956 Dandenong Rd, Clayton, Victoria (**Principal Employer**)

AND

Sunsuper Pty Ltd ABN 88 010 720 840 of 30 Little Cribb Street, Milton, Queensland (**Trustee**)

Background:

- A Sunsuper Pty Ltd is the Trustee of the superannuation fund known as Sunsuper Superannuation Fund (**Fund**), governed by a trust deed dated 1 October 1987 as amended (**Trust Deed**).
- B Sunsuper Pty Ltd and the Principal Employer have entered or will enter into a Participation Deed (**Participation Deed**).
- C Under the Participation Deed, the Principal Employer becomes:
- (a) a Participating Employer in the Fund; and
 - (b) the principal sponsoring employer, under the Rules of the employer plan (**Plan**) established in the Fund pursuant to the Participation Deed.
- D This deed is:
- (a) an application by the New Associated Employer for admission as a Participating Employer of the Fund, under clause 3.1 of the Trust Deed;
 - (b) a nomination of the New Associated Employer as an Associated Employer of the Plan, under clause 2.1 of the Participation Deed; and
 - (c) acceptance by the Trustee of that application.

OPERATIVE PROVISIONS:

- 1 The Principal Employer nominates the New Associated Employer for admission as an Associated Employer of the Plan.
- 2 The New Associated Employer:
 - (a) applies to be admitted as a Participating Employer in the Fund and an Associated Employer under the Rules of the Plan; and
 - (b) agrees to be bound by the Rules of the Plan in accordance with the Participation Deed.
- 3 The Trustee accepts the application and admits the New Associated Employer named as a Participating Employer in the Fund effective on the Commencement Date.

Interpretation

- 4 Terms defined in the Trust Deed or the Participation Deed have the same meaning in this deed.
- 5 This deed is subject to, and governed by, the laws of Queensland, Australia.
