### How to make payments

To make payments in Employer Online you can use either:

- Web Input: enter employees' contributions via a contribution grid
- Web Upload: upload a payroll file direct from your payroll system

### **How to use Web Input**

- 1. Login to Employer Online
- 2. Create a new contribution period
- 3. Once you have created a new period, a list of your current employees will appear. Simply enter the amount to be paid for each employee totals are calculated automatically
- 4. Once you have entered all your amounts, click next and a total amount will be displayed for final approval
- 5. Once you click 'Submit' your payment instructions will be displayed. If you have chosen direct debit that amount will be debited from your nominated bank account and distributed to each employee's Australian Retirement Trust account.

It's important to note that you must submit your payment via your financial institution the same day as submitting the contribution grid.

#### How to use Web Upload
