SuperRatings Assessment

Australian Retirement Trust is one of Australia's largest superannuation funds following the merger of QSuper and Sunsuper in March 2022. ART-QSuper-Accumulation Account provides for the retirement needs of Queensland Government employees and their families. The fund was nominated as a finalist for the 2023 Smooth Ride award.

The product provides a tailored investment strategy that considers a member's age and their account balance. Choice members may also select from 4 Diversified and 4 Single Sector options, as well as Self Invest, which provides access to Direct Shares listed on the S&P/ASX 300, a range of Exchange Traded Funds (ETFs) and Term Deposits. The Lifetime Outlook option outperformed the relevant SuperRatings Index over the 1-year period to 30 June 2022; however, underperformed across other time periods assessed.

Fees are lower than the industry average across all account balances assessed. Administration fees paid in excess of \$875 are refunded to the member in July of the following financial year. The fund does not charge an investment switching fee or a buy sell spread.

The insurance offering allows eligible members to apply for up to \$3 million of Death cover and up to \$3 million of Total and Permanent Disability (TPD) cover. Income Protection with a benefit period of 2 years, 5 years or to age 65, covering up to 87.75% of salary, is available following a 30-, 60- or 90-day waiting period.






